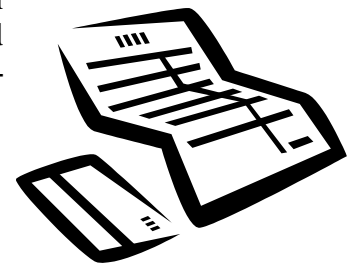

## PSC Rulemaking: Customer Billing, Backbilling and Unauthorized Use (Docket No. 120246-WS)

The FPSC adopted the amendments to Rule 25-30.335, F.A.C., *Customer Billing* and 25-30.350, F.A.C., *Backbilling*, and new Rule 25-30.351, *Unauthorized Use*. The amendments to 25-30.335 authorize an estimated bill if the utility is unable to obtain an actual meter read; require that the bill indicate it is an estimated bill; require the utility timely correct problems within its control causing the need for an estimated bill; prohibit the use of an estimated bill more than four times in a 120-month period for circumstances within the utility's control; require the utility provide a written explanation upon the issuance of a second estimated bill within a six-month period together with utility contact information and the FPSC's toll-free complaint number; and require the utility maintain records for two years regarding estimated bills. The amendments to Rule 25-30.350 retitle the rule "Underbillings and Overbillings for Water and Wastewater Service" and provide the method for recalculating a bill when a customer is underbilled and for refund of the overcharge to a customer in the event of overbilling and allow a customer to elect a one-time refund (if the refund is in excess of \$20) or as a credit to future billings. New rule 25-30.351 addresses billing a customer for the unauthorized or fraudulent use of service or meter tampering.



The amendments and new rule took effect June 28, 2013.

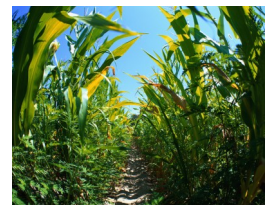

### **PSC-13-0146-CFO-SU**—Date Filed: 4/3/2013

Order grants TKCB, Inc.'s request for confidential classification of trade secret information that includes contract terms and values and information related to competitive business interests.

The purpose of new Rule 25-30.351, is to clarify the process for situations involving the fraudulent or unlawful use of services by customers.

Order suspends Ni Florida, LLC's requested final water and wastewater rates for service in Pasco County.

### **PSC-13-0181-FOF-WS**—Date Filed: 4/29/2013

Order closes the docket and finds Hidden Cove, Ltd, providing water and wastewater service in Polk County, has complied with metering and reporting requirements of Order No. PSC-08-0262-PAA-WS and that a revenue-neutral rate restructuring is not appropriate.

### **PSC-13-0187-PAA-WS**—Date Filed: 5/2/2013

Proposed Agency Action (PAA) Order approves an increase in water and wastewater rates for service on Orange County by Pluris Wedgefield Inc. (Wedgefield or Utility). The quality of product, operating condition of the plant and facilities and Utility's attempt to address customer satisfaction were all found to be satisfactory. Adjustments to rate base including a reduction in wastewater plant were made based on Staff's audit finding. However, with respect to the adjustment for the wastewater plant the Utility was not precluded from receiving a return on its investment in a subsequent case "if more information becomes available to the utility." Also approved were pro forma adjustments for specified plant improvements. The water treatment plant was found to be 100% used and useful (U&U), the wastewater treatment plant 72.1% U&U and the water distribution and wastewater collection systems 85.1% U&U. Based on the existing Commission-approved leverage formula the return on equity (ROE) was set at 10.88% and the weighted cost of capital at 8.36%. Several adjustments were made to the costs allocated to the Utility from the parent company, Pluris Holding, LLC (Pluris) including costs relating to accounting, automobile travel, dues and subscriptions, and wages. Proforma adjustments to O&M expenses were made for customer call center services, the controller's salary, and taxes. Adjustments were also made to rate case expense. The Base Facilities Charge (BFC) and three-tier inclining block gallon charge for residential service was continued, with the BFC allocation being set at 35%. The rate structure for water service for the non-residential class was a continuation of the BFC and gallonage charge, with the BFC also being allocated 35% of revenue recovery. The rate structure for wastewater service was a continuation of the BFC and gallonage charge structure for both residential and nonresidential service. A repression adjustment was made for water service for consumption over 5,000 gallons per month. A refund of a portion of interim rates for both water and wastewater service was required.

Amendatory Order corrects incorrect rate factors and figures in Tables 12 and 13 of Order No. PSC-13-0187-PAA-WS.

### **PSC-13-0196-PAA-WS**—Date Filed: 5/15/2013

Order grants water and wastewater certificates to Bluefield Utilities LLC (Bluefield or Utility) for service in St. Lucie County and approves the settlement agreements between the City of Port St. Lucie (City) and the Utility and St. Lucie County (County) and the Utility, which were the bases for the City and County withdrawing their protests to the issuance of the certificates. The water and wastewater service is for land development projects under consideration by the Utility's parent company, Evans Properties. The Proposed Agency Action (PAA) portion of the Order approves the Utility's projected rate base, cost of capital, net operating income, rates and rate structure, service charged, service availability policy and charges and AFUDC rate.

### **PSC-13-0197-FOF-WU**—Date Filed: 5/16/2013

Final Order grants a rate increase to Water Management Services, Inc. (WMSI or Utility) for water service in Franklin County,. The Commission had previously entered a Proposed Agency Action (PAA) Order in the case, and that PAA Order was protested by the Office of Public Counsel (OPC). The calculation of previously approved adjustments to working capital resulted in a negative working capital, so for ratemaking purposes the working capital allowance was set at zero. The cost of capital was set at 5.51%, the expense for accounting service was reduced to the same amount allowed in the last rate case, and reductions were also made to travel expenses and rate case expense. The net gain on sale of land and other specific assets of the Utility were amortized over a five-year period. The Utility is required to make quarterly reports showing that payments are being made to vendors from the rate case expenses collected from the Utility's customers. A reduction in the President's salary was also made to reflect additional interest due to the Department of Environmental Protection (DEP) as a result of missed interest payments by the Utility and the Utility was required to file quarterly reports "delineating all advances, loans, investments, notes receivable and accounts receivable between WMSI and the President and associated companies including the date amount, and reason for the transaction(s)." The rate structure approved was the same as set forth in the PAA Order in the case, and increases in the service availability charge were approved. A refund of interim rates was required.
