CHAPTER 2015-129, LAWS OF FLORIDA

On June 10, 2015, Governor Scott signed into law Committee Substitute for House Bill 7109 (CS/HB) affecting the Florida Public Service Commission (FPSC) the Public Service Commission Nominating Council (Nominating

Council) and the financing of cost relating to nuclear generating asset retirements and abandonments. The law, Chapter 2015-129, Laws of Florida, prohibits FPSC Commissioners from serving more than three consecutive terms, and requires meetings, workshops, hearings and other proceedings attended by two or more FPSC Commissioners to be streamed live on the internet and a recorded copy of such meetings workshops, hearings and proceedings be made available on the FPSC's website. FPSC Commissioners are required to annually complete four hours of ethics training covering Section 8 of Article II of the State Constitution, the Code of Ethics for Public Officers and Employees and the laws relating to public records and public meetings.

The law also addresses prohibited ex parte communications which will now include communications regarding a proceeding under sections 120.569 and 120.57, Florida Statutes, "that is pending before the Commission or that he or she knows or reasonably expects will be filed with the Commission within 180 days after the date of any such communication." The Legislature found it is in the public interest for Commissioners to be educated and informed on regulatory policies and developments "through active participation in meetings that are scheduled by organizations that sponsor such educational or informational sessions, programs, conferences, and similar events that are duly noticed and open to the public." However, the prohibitions regarding ex parte communications remain in effect at such meetings and Commissioners are to refrain from commenting on or discussing any currently pending proceeding or one that will be filed within 180 days after the meeting. Further, Commissioners are to use "reasonable care to ensure that the content of the educational or other session in which the Commissioner participates is not designed to address or create a forum to influence the Commissioner or any proceeding" to which the ex parte prohibition applies. The governor may remove from office a Commissioner who has willfully and knowingly violated the prohibition on ex parte communications and must remove a Commissioner from office for a willful and knowing violation after a previous finding by Ethics Commission of a willful and knowing violation in a separate matter.

New provisions affecting the electric and gas industry were also added. Finally, the law amends provisions regarding the Nominating Council requiring that persons who are employed to influence the actions of the Nominating Council register as lobbyists pursuant to, and comply with, the provisions of Section 11.045, Florida Statutes.

The overearnings are attributed to significant customer growth.

# PSC-15-0178-TRF-WS through PSC-12-0190-TRF-WS-Date Filed: 5/6/2015

Orders approve a miscellaneous service charge for all 13 regulated utilities of U.S. Water Services (U.S. Water) to cover cost incurred by utilities for customers who opt to pay their water or wastewater bill by credit or debit card on line or by way of the telephone. A charge of \$2.60 was approved for: HC Waterworks in Highlands County; for Harbor Waterworks, Inc. in Lake County; LP Waterworks in Highland County; Sunny Hills Utility Company in Washington County; Jumper Creek Utility Company in Sumter County; Lake Idlewild Utility in Lake County; Lakeland Waterworks, Inc. in Lake County; Lake Osborne Waterworks, Inc. in Palm Beach County; Brendenwood Waterworks, Inc. in Lake County; Country Walk Utilities in Highland County; Brevard Waterworks, Inc. in Brevard County; Woods Utility Company in Sumter County; and Raintree Waterworks in Lake County.

#### **PSC-15-0191-PCO-WU**—Date Filed: 5/8/2015

Order extends the amount of time that Water Management Services, Inc., which provides water service on St. George Island in Frankling County, had to complete financing and construction requirements of pro forma plant projects. The time was extended from December 22, 2014, to December 31, 2015.

#### **PSC-15-0207-FOF-WS**—Date Filed: 5/26/15

Order approves Pluris Wedgefield, Inc.'s application to amend Certificate No. 404-W and 341-S to include in its water and wastewater service territory in Orange County a newly constructed school in Orange County. This amendment adds fewer than 100 equivalent residential connections.

#### **PSC-15-0208-PAA-WS**—Date Filed: 5/26/15

Proposed Agency Action Order (PAA) Order approves an increase in water rates and wastewater rates for Labrador Utilities, Inc. in Pasco County. The overall quality of service for wastewater was deemed satisfactory, but the quality of service for water services was deemed marginal due to insufficient efforts to engage its customers to discuss and resolve continuing dissatisfaction with the quality of water. The water treatment plant was found to be 79.94% used and useful (U&U) and the water distribution and wastewater collection systems were found to be 100% U&U. A working capital allowance was allowed using the one-eighth of the operation and maintenance expenses formula. The return on equity for wastewater was set at 10.43 % and 10.18% for service of water based on the Commission's leverage formula. Various adjustments were made to test year expenses. The rate increase for water service was 16.65% and the rate increase for wastewater service was set at 32.81%. The rate structure approved for residential water service was a base facilities charge (BFC), designed to recover 50% of the revenue requirement due to the seasonal nature of the customer base and a uniform gallon charge for all customers. The rate structure approved for residential and general wastewater customers was a BFC designed to cover 50% of the revenue requirement and a gallonage charge. The gallonage cap was reduced to 6,000 gallons.

Order amends the table for GCP Fairfield Village, LLC Monthly Water Rates found in Schedule No. 1 which reflects incorrect rates.

Order approves the transfer of majority operational control of Sunlake Estates Utilities, LLC in Lake County to Sun Communities Operating Limited Partnership. The existing rates and charges remain in effect until a change is authorized by the Commission in a subsequent proceeding.

Consummating Order No. **PSC-15-0215-CO-WU** and Order Nos. **PSC-15-0218-CO-WS** through **PSC-15-0229-CO-WS** filed on 6/1/15 make effective and final Order Nos. PSC-15-0178-TRF-WS through PSC-15-0190-TRF-WS approving a miscellaneous service charge for all 13 regulated utilities of U.S. Water Services located in Highland, Lake, Sumter, Washington, Palm Beach and Brevard Counties.

#### **PSC-15-0216-CO-WS**—Date Filed: 6/1/15

Consummating Order makes effective and final PSC-15-0173-PAA-WS approving settlement proposal for possible overearnings by Southlake Utilities, Inc. in Lake County.

## **PSC-15-0233-PAA-WS**—Date Filed: 6/3/15

Proposed Agency Action Order (PAA) Order approves an increase in water rates and wastewater rates for Sanlando Utilities Corporation in Seminole County. The overall quality of service for water and wastewater services was deemed satisfactory. The water treatment plant and the water distribution and wastewater collection systems were found to be 100% used and useful (U&U). A working capital allowance was allowed using the balance sheet method used by Class A utilities. The return on equity for wastewater and water services were set at 10.53 % based on the Commission's current leverage formula. Various adjustments were made to test year expenses. The rate increase for water service was 9.90% and the rate increase for wastewater service was set at 5.32%. Part of the wastewater revenue requirement was shifted to the water system. The rate structure approved for residential water service was a base facilities charge (BFC), designed to recover 21.45% of the revenue requirement and a uniform gallon charge for general service water customers with a three-tiered gallonage charge for residential customers. The rate structure approved for residential and general wastewater customers was a BFC designed to cover 50% of the revenue requirement and a uniform gallonage charge. A 10,000 wastewater gallonage cap was set for residential customers and 1.2 times that for general service. An across-the-board increase of 5.32% for reuse wastewater customers was approved.

Order amends PSC-15-0233-PAA-WS by removing the ninth ordering paragraph on page 44 regarding reports on billing which was inadvertently included but does not apply in the case.

Order acknowledges the transfer of Francis I Utility, LLC wastewater assets to the City of Sebring in Highlands County.
