The Florida Public Service Commission is charged with the responsibility of economic regulation of Florida's investor-owned utility companies. Public Service Commissioners are required to be knowledgeable in public affairs, laws, economics, accounting, engineering, finance, natural resource conservation, energy and other areas relating to the duties and responsibilities



of the Commission. As part of this collegial body, Commissioners must preside over contested matters, rulemaking and declaratory statement proceedings within the Commission's jurisdiction. Commissioners also participate in shaping state and federal regulatory law and policy by issuing written comments and through their participation in National Association of Regulatory Utility Commissioners and other professional organizations. Commissioners are responsible for making executive-level decisions relating to the structure and operation of the Commission.

Served as the Commission's chief legal counsel. Supervised the Commission's legal personnel consisting of 27 attorneys and 12 administrative/secretarial positions.
